With reference to the "Cylinder" machine. I have phoned an old friend of mine who has specialised in these models for years. He tells me that it is impossible to give a firm price until he sees the actual record, for the simple reason that these models are "gear driven"- the gear has to be cut to the same number of turns as the grooves in the record (per inch)

But he says that it is quite safe *towards* the records as he can adapt and cut any specific gear to suit the record. As a rough estimate he says that £8.00 should cover the entire cost of the complete outfit.

With reference to the Cabinet Models. I am still further improving the appearance of the cabinet. I'm cleaning up the lines in various ways. The modern tendency in cabinet design is much better than any previous design and ties in with any scheme of furniture. It is very simple in its appeal, everything flush. No awkward corners, carving, beading no dust-traps. The lines of the cabinet, the beauty of the wood used, (by careful matching of grain) is the only offence to the eyes. Such a cabinet needs very accurate expert cabinet work.

I enclose my leaflet in the cabinet but if you desire to find your own price for this model

I will have a supply of these leaflets made for you with the price left blank or any price you wish to put in.

My expenses in Grape St are totally & fundamentally mostly different than when I was trading in Holborn. I say here definitely that I cannot afford to give Mr West 25% and you 15%. Also I should like you to note that any orders you may have must of necessity be confirmed in writing accompanied by the name & address of coustomers to whom the machines is going & also to whom I am to send the account. Enclosed please find cheque value £35-11-0 being balance due to you as Commission on sales up to & including todays date. As I have previously pointed out, I cannot perpetuate a 15% commission- but only 5% on all personal orders in future. Will you kindly make a note in your price list that the Overseas Teak Model is now £17.10.0 not £16.0.0 as heretofore the reason for this is I am fitting a larger more powerful motor. Mr E.M.Ginn agrees to allow Mr C.K. Ogden the CASH discount of fifteen per centum on a Gramophone manufactured by the said E.M.Ginn known to them both as a "Mark Seven" and Ten per centum in all other models produced by Mr E.M. Ginn. It is definitely agreed between them that the aforesaid mentioned commission will only be allowed Mr C.K. Ogden on definite orders received by Mr E.M. Ginn in writing. It is also agreed this commission will only be paid to Mr C.K. Ogden when the gramophone or gramophones are actually paid for either by Mr C.K. Ogden or the purchaser.

Your letter to hand this morning. With reference to the names mentioned therein.

You have already been paid commission for 2 of them. Mr Eyre and Mr *James* Taylor. The other two men have up to date not made any orders.

Mr Ginn assumes that he is not prepared to pay any commission on orders that do not come absolutely from you own personal introduction. Which to my mind is absolutely fair. Imagine for a minute each of four persons mentioned in your comm. Introducing one each & they in turn introducing someone else, a position would eventually be created which would be intolerable.

The foregoing will doubtless covey to you that should either Mr Chance or Mr Powell eventually buy a machine you will not be entitled to any commission on the sale.

Dear Mr Ogden,

I have just returned from a very busy day and Mr Green has explained to me all your troubles. We will take them in rotation.

- 1. Electrical Outfit. These have proved to be a far greater loss to methan they possibly could have been for you, personally I have lost about £700-0-0 on these big outfits.
- 2. Your Commission, the last cheque paid to you included every model that we could trace directly to you. You must remember that really every one of my customers is sent here by someone & it is quite impossible to trace the exact origin of any sale, in addition all my salesmen are paid a commission on every machine they sell, therefore unless I have some really definite means of knowing that any order is directly influenced by yourself, I can neither trace or pay commission.
- 3. Your position, Mark 10 was introduced after my arrangement to pay you 15% commission & the profits in this model are cut down to a minimum. Therefore, your commission must be 15% on all models in production at the moment except Mark 10. On this you will receive 10%

I have no desire to be rude to you but if you could possibly estimate the value of my own and my staffs time that has been wasted by your good self admittedly with the best intensions but with little or no result you would be exposed.

We'll always be pleased to supply yourself & many of your friends but you must give me more definite means of tracing your orders if you wish to draw any commission on same.

Mr Davey may join my staff in the new year & then I will re-enter the Radio field with every confidence.

Dear Mr Ogden

You will be surprised to hear from me but as on one knows the true facts of my case better than you, I thought I would put you on fact with the latest details.

You will remember that it was through your introduction that I met Mr West, you will also remember the trouble we had to come to terms over the agreement. Now I appear to have broken the agreement & Mr West has got my business in his own hands after paying me £1.000 for the name EMG.

He also refused to allow me a second chance, he says that you have caught him twice for a very considerable amount & that he was not going to be caught again. Mr West did not tell me this direct but through a third party, he has refused to see me personally, still your dealings with Mr West are nothing at all to do with me & having myself lost my business thought Mr West's bitterness, I think I can better realise your position. My first step was to see Maj.Stone of the "Gramophone", he has agreed to accept my adverts & told me to get into touch with you at once. I have the designs all ready & in fact have started production of a new model which will be very far ahead of anything that EMG have ever produced. This will

be marketed under the name of the EMGinn "Expert" model. A new range of hand-made soundboxes will also sold under the same name.

I am sure of the results and would very much like to see you as soon as possible. I think that we can do a very big business in some form of combination. I will be pleased to see you at any place or time you desire, if urgent, wire or phone.

Of course I am wise after the event but all along I have been weak and guided by others.

Re' the future. I am sure my new model will be a success & if I can do anything to make up to you for what you have lost in the past, please let me know. I have not fixed up a new address yet but as soon as I do so I'll let you know.

I will also be advertising in the "Gramophone".

Again wishing you a speedy recovery.
